1.1 The subject of the contract shall be the supply, delivery, unloading and installation of the following supplies:

1. **Combined machine backhoe-loader (1 pc);**
2. **Hydraulic hammer (1 pc);**
3. **Grapple with rotator (1 pc).**

in one lot only.

The contractor is to deliver and install the supplies at locations within the Municipality of Bar, Montenegro:

1) Regional Sanitary Landfill MOZURA, 85000 Kunje, Bar Montenegro

After the supply, delivery, unloading and installation of the above listed supplies, the contractor is to provide training in the use of the Regional Sanitary Landfill Možura for the designated staff.

The time limits for the delivery and installation shall be 2 months (60 days) from contract signature and the Incoterm applicable shall be DDP⁴. The implementation period of tasks shall run from the date of contract signature, January 24nd, 2025 to March 24th, 2025.

Subsequent to delivery and installation, the contractor is to provide warranty of **xx** months and 2000 working hours of the machine and additional equipment.

1.2 The contractor shall comply strictly with the terms of the special conditions and the technical annex.

1.3 The supplies which form the subject of the contract must be accompanied by the spare parts described by the contractor in its tender and by the accessories and other items necessary for using the goods over a period of 1 (one) year, as specified in the instructions to tenderers.

Article 2 Origin

No rule of origin is being applied to this contract

Article 3 Price

3.1 The price of the supplies shall be that shown on the financial offer (specimen in Annex IV). The total maximum contract price shall be **<insert price>** EUR.
